### Vendor/Exhibitor/Non-Profit Agreement

- Vendor/Non-Profit agrees to abide by all applicable laws, ordinances, and regulations pertaining to health, fire prevention, public safety, business licenses and sales tax permits.
- Vendor/Non-Profit must be open and staffed during all hours of the event. All Vendor/Non-Profit organizations are responsible for securing their exhibit after closing and must clear all debris by no later than 7 pm on Saturday, December 11, 2010.
- The Vendor/Non-Profit agrees not to hold responsible Bay Area Friends of Tibet (BAFoT) or Tibetan Association of Northern California (TANC) or any of its members from any and all claims, causes of action suits, damages, theft, injuries, and losses to any person or goods arising out of or connected in any way with the renting of space at Tibet Day 2012.
- Vendor/Non-Profit agrees to maintain dignity and the integrity of the event and will not perform any harmful acts.
- As the Producers of the event, we reserve the right to ask any Vendor/Non-Profit or its employees to leave if felt that they are not acting in the best interest of the festival and its attendees.
- Vendor/Non-Profits agree to permit photography of their booths during the 2012 festival by festival staff to be used for the purposes of promoting and advertising future events.
- All photography taken by BAFoT or TANC will remain the property of BAFoT and TANC and will not be sold or used for other purposes.
- The producers of the event will not be liable for any refunds or any other liabilities in case of a disruption of the event due to reasons out of our control including but not limited to weather, fire, public enemy, terrorist strikes, statutes, ordinances or any other cause. BAFoT and TANC has the right to cancel the event and return all fees to the Vendor/Non-Profits by December 31st, 2012.
- Vendor/Non-Profit agrees there are to be no refunds once the reservation has been confirmed except in the event that TANC and BAFoT has canceled the event.
